Overview

In 2019, the environment of the CIPM MRA is vastly changing. The international standards ISO/IEC 17025 and ISO 17034 have been revised, and NMIs/DIs are improving their systems to complete their transition to the new standards, within the three-year period agreed between the CIPM and ILAC. For the CIPM MRA itself, the BIPM is making an investment to renew the KCDB infrastructure, KCDB 2.0 will include both documentation and web-based system.

Considering the importance of these changes, the APMP TCQS is organizing its Technical Committee Workshop as a joint event with the BIPM. The Workshop is also financially supported by the APMP as one of the TCI (Technical Committee Initiative) Projects, TCQS_01_TCQS 2019.

All institutes and their participants are invited to attend Day 1 and ask any questions related to the CIPM MRA, KCDB2.0 and transitions of international standards ISO/IEC 17025 and ISO 17034.

All institutes with participants on Day 2 are required to prepare and deliver a presentation. Each Institute selects one participant to present on behalf of the institute..

17:15-17:45 Early days of the CIPM MRA and implementation of the APMP QS Review Process

This talk recalls the early days of the implementation of the CIPM MRA within the APMP. As the basic structure and processes developed during the early days still exist as the APMP rules, the lecture will detail the spirit and minds of the early days of building the quality system review process within the APMP. Suggestions to improve the review process to underpin the reliability of the monitoring of the Quality Managements System implemented at each NMI/DI within the APMP will be discussed.

17:45-18:15 Transition to ISO/IEC 17025:2017 & ISO 17034:2016, an accreditation point of view

This talk will discuss the transition to the new standards, from the view point of the Australian accreditation body assessing an NMI, focusing on calibration/testing laboratories and reference material producers. Issues based on experience through accreditation assessments and considerations for the smooth transition of the laboratories/producers will be presented.
